Annual Scientific Meeting, Dublin, Wednesday 22nd to Friday 24th November

Rachel's theme for the Dublin ASM is compassionate leadership. We will be joined by Dr Alan Lumsden (Houston Methodist, USA), Prof Kak Khee Yeung (VU University Medical Centre Amsterdam, The Netherlands) and Dr Anahita Dua (Massachusetts General Hospital, USA) as guest speakers.

We will also have sessions with updates from Prof Andrew Bradbury on the Basil trials and Prof Chris Imray on his ASPIRE 2022 polar expedition.

There are new joint sessions with allied vascular societies and an interactive session on the Friday exploring to the future of vascular service delivery, including the impact of artificial intelligence.

The Society received over 250 abstract submissions. These will be presented at the PAD, Aortic, Academic and Venous sessions (Wednesday morning) or as electronic posters (judged on Thursday).

For the first time we will be using the **Slido app** at the ASM to allow delegates to pose questions electronically, and for voting.

Rachel Bell and Douglas Orr have tasted the venue coffee and assure me it is of high quality and that members attending the Dublin ASM will not be disappointed!

Vascular GIRFT Leads Appointed

It is with great pleasure that I can announce that **Rachel Bell** and **Jon Boyle** have been appointed by NHS England with the Vascular Society as joint Vascular GIRFT Lead from December 2023. Their joint appointment ends a 2 ½ year hiatus since Professor Mike Horrocks stood down from this role.

Under the leadership of Prof Tim Briggs, GIRFT (now a part of NHS England), has an ambitious work programme. The first workstream for vascular services is **Clinically led Speciality Outpatient Guidance**. This document will be a template for standardisation of clinical prioritisation, optimising outpatient capacity and resources in outpatients to improve patient pathways and experience.

This project is progressing well with our supplier, Light Media, and we are on track for a new VS website launch prior to next year's March membership renewals.

Audit and Quality Improvement

National Vascular Registry Report 2023

The 2023 NVR '**State of the Nation Report**' is due for publication on 9th November 2023. Two significant changes from previous years' reports are a new format, as required by HQIP, and the move of iliac branch procedures (IBD/IBE) from the complex to standard EVAR dataset.

NVR data will be validated in 2024 by a team from VASCUNET. This is work deferred during the Covid-19 pandemic and supports the NVR's commitment to international vascular registries.

PAD QIF -CQUIN (England)

In England, the PAD QIF –CQUIN is now running for a second year with revised targets at 45%-65% of admitted patients with CLTI are revascularized withing 5 days (endovascular or open surgery).

Research

Clinical Trials Day

The Research Committee held a successful clinical trials day in Leicester on the 21st of June 2023. Funded by the RCS Eng. SSL budget this event was free to attend. There were over 80 attendees from a variety of research backgrounds.

RCS England Research Fellowships

Council was disappointed when neither of our two joint VS and RCS Eng. Vascular Research Fellowship places were appointed for 2023-24. This is despite our research fellows having a strong track record for delivery and a high standard of applicants with both research and quality improvement projects.

Council members are in discussion with RCS Eng. as to changes to the selection process to prevent this happening again.





NEW Joint BSIR and RCR Research Fellowship The VS has agreed a jointly funded BSIR/CF/RCR research fellowship.

The Vascular Society notes the passing this month of **Professor Roger Greenhalgh** (6.10.23 aged 82 years) and **Simon Lau** (1.10.23 aged 32 years).

Prof Greenhalgh is a past President, retired Professor of Surgery at Charing Cross, led the UK Small Aneurysm Trial (UKSAT) and EVAR Trials (EVAR 1 & 2), and founded the Charing Cross International Vascular Symposium.

Simon studied at King's College London, then his career has spanned the United Kingdom via Wales, Plymouth, Glasgow, Scunthorpe, and Sheffield.

Simon was in his ST4 vascular surgery year in Sheffield when he became ill.
